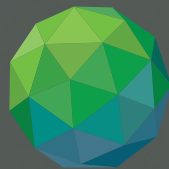

The Independent Integrity Unit (IIU) ensures that all GCF staff, external stakeholders, implementing entities, and intermediaries relating to GCF adhere to the highest standards of integrity to safeguard the lawful and efficient utilisation of GCF resources.

WHAT WE DO



PROACTIVE PREVENTION

The IIU takes a proactive approach to deter occurrences of fraud, corruption, and other Prohibited Practices in GCF-funded activities by establishing integrity policies, proactively assessing and mitigating integrity risks, and recommending further improvements to existing GCF policies and procedures.

The IIU employs measures to detect compliance failures and potential integrity violations (red flags) in GCF operations through a risk-based oversight of GCF-funded projects and programmes.



INVESTIGATION

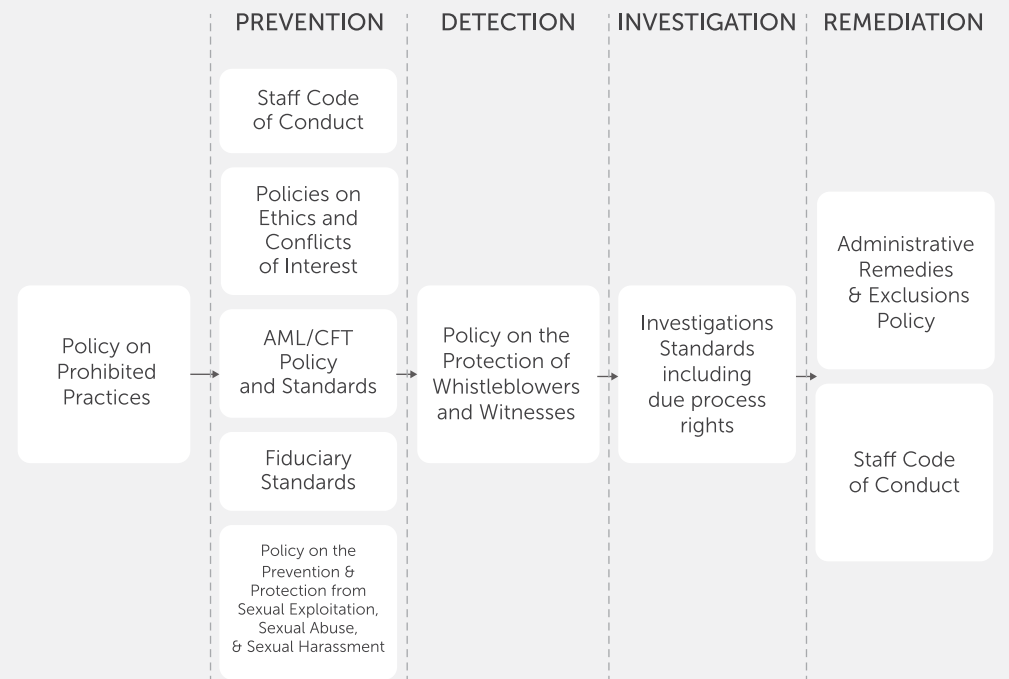
As an initial point of contact, the IIU investigates allegations of Wrongdoing, including Misconduct and Prohibited Practices, in line with international best practices and in close cooperation with relevant counterpart authorities.



AWARENESS RAISING AND CAPACITY BUILDING

The IIU promotes awareness of GCF integrity standards to GCF staff and implementing entities, and helps build capacities of Accredited Entities to effectively prevent, respond to, mitigate, and remedy Prohibited Practices. The Unit also collaborates with relevant counterpart offices of other international organisations to ensure it is at the frontier of relevant practices.

WHISTLEBLOWER PROTECTION

Whistleblowers and Witnesses play important roles in contributing to the mission of the GCF.

The GCF endeavours to empower anyone to report suspicions of Wrongdoing in good faith and without fear of retaliation, acknowledging the critical role of Whistleblowers and Witnesses in exposing Prohibited Practices and other acts of Wrongdoing in order to effectively prevent, detect, and mitigate such malfeasance and to safeguard the resources entrusted to its care.

PROTECTIONS AVAILABLE

ANONYMITY AND CONFIDENTIALITY

Any person may submit a report of suspected Wrongdoing anonymously. Whistleblowers or Witnesses may request confidentiality regarding their identity, the identity of their close family member(s) or associate(s), and specific information conveyed.

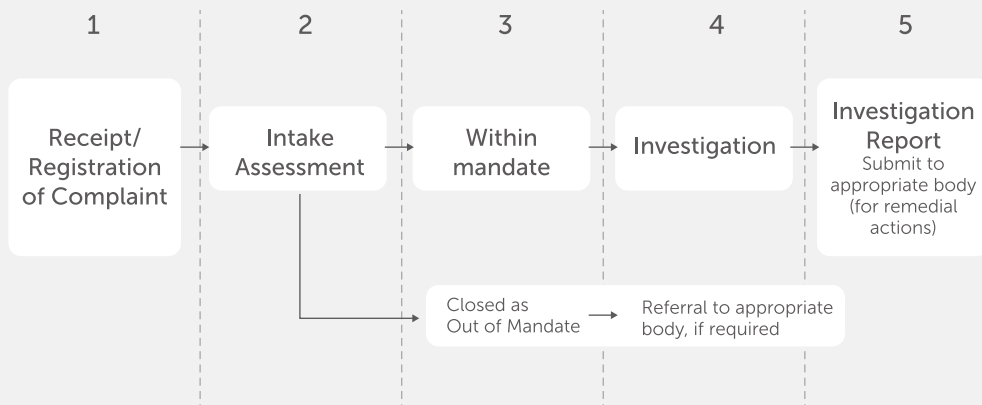
INTERIM PROTECTION

Whistleblowers and Witnesses will be accorded, at their request, interim protection without delay, to safeguard their safety and well-being.

REMEDIAL MEASURES

Where Retaliation against a Whistleblower or Witness has been substantiated, the GCF will implement remedies.
